2 **Statement of the Case**

3 Based upon the evidence presented, the Court finds the following facts:

4 1. In or about July, 2005, plaintiff Eagle World Media, Inc. ("Eagle") entered into a
5 contract with defendant Face2Face Animation, Inc., ("F2F") by which F2F agreed to pay Eagle a 5%
6 (Five Percent) investment finder's fee for any investment that Eagle found and that was actually made
7 in F2F.

8 2. Eagle found Edentify, Inc. which, as a result of Eagle's efforts, transferred 7.5 million
9 shares of its stock to F2F, along with a warrant to purchase an additional 1 million share of Edentify
10 stock, in exchange for rights in certain of F2F's intellectual property.

11 3. Eagle learned about these share transfers in or about September 9, 2005, when its
12 details were disclosed in a Schedule 13D and Form 3 filed by F2F with the U.S. Securities and
13 Exchange Commission and released to the public on the SEC's Edgar computer website.

14 4. Eagles demanded its 5% finder's fee. F2F refused. This lawsuit followed.

15 The court makes the following findings of law:

16 1. "Damages for a breach of contract are to be determined as of the time of the occurrence
17 of the breach." 22 AM.JUR.2D "Damages," § 78, at p. 113. The instant breach occurred on or about
18 September 9, 2005 when Edentify stock was trading at a price of 73¢ per share. At that price, the
19 finder's fee due to Eagle is 7.5 million shares x .73 per share x .05 (5%) = \$273,750.00.]


