directing such payment prior to the accrual of such arrears, it is therefore

ADJUDGED that the Respondent failed to obey the Order of this Court in that Respondent failed to pay the sum of \$ 2079 00, which amount the Court finds to be the arrears due and owing under the Order, and that such failure was willful, and it is further

ADJUDGED that the Respondent knowingly, consciously and voluntarily disregarded the obligation under a lawful court order, and it is

ORDERED that judgment be entered in favor of the Petitioner against the Respondent in the amount of \$2079 00, plus interest (C P L R 5004) from the date of this judgment until it is satisfied, and it is further

ORDERED that a certified copy of the judgment may be filed in the county clerk's office in accordance with Section 460 of the Family Court Act
